SUBMISSION OF MATERIALS TO MAISON BATTAT INC. And Worldwide Release of All Copyrights to Story, Right to Use Author's (even a Minor Child's) Name, Right to Use and Publish Photographs of Minor Author, Transfer of Copyrights to Drawings Accompanying Story and Transfer of Author's Rights of Publicity - All to Maison Battat Inc.

I, a custodial parent or legal and/or financial guardian of the "Minor Child", hereby represent that said Minor Child through my financial and custodial guardianship, being fully mindful of his/her rights and safety, and with all other custodial authority (hereinafter collectively "custodial authority") hereby grant Maison Battat Inc. of Montreal, Canada and any of its related entities and/or subsidiaries, including all customers and resellers of the same (to the extent they purchase product/services from Maison Battat Inc. referring, containing or concerning any or all of the Work(s) of the Minor Child) as provided by the Custodial Authority to Maison Battat Inc., a worldwide Release of copyrights to the Works of the Minor Child, as provided to Maison Battat Inc. whether orally, by video, by writing, sketches, or otherwise, the full Copyrights to the Works, the story, the right to use the Minor Child's name and to exclude the same, as Maison Battat Inc. unilaterally determines, the Minor Child's picture, photographs sound recordings, drawings, sketches, wording, reading, etc. of the Minor Child's, and I hereby, on behalf of the Minor Child, convey and Release to Maison Battat Inc. all copyrights to the Works and any accompanying pictures, drawings, sketches, readings, videos, photographs, etc. which are provided to Maison Battat Inc., and a full and complete transfer of all of the Minor Child's rights of publicity, as well as commercial and/or non-commercial rights along with a full release to Maison Battat Inc. to use, in any form, the submitted materials comprising any and all of the following or related materials, whether in written, video, printed, oral form or otherwise – all rights to the story, storyline, play, photos, pictures, sketches, paintings, writings, drawings, audio or video presentations of the same, along with the name of the Minor Child, a submitted or obtained photograph of the same (hereinafter "the Materials"), for commercial use whether separate from or along with sales of Maison Battat Inc.'s sale or offer for sale of any products, including storybooks, workbooks, videos, animated presentations, actual OUR GENERATION® dolls, doll clothing, a doll-related book or booklet, doll houses, settings, accessories, or other, all without any royalties being due or payable to the Minor Child nor to the Custodial Parent or Authority for

the Minor Child, it being clearly understood that this document is a complete release to Maison Battat Inc. of all of the Minor Child's rights to the submitted Materials including all rights within and without the US, i.e., including all worldwide copyrights, subject to Maison Battat Inc.'s agreement to provide, along with the sale of any products or services relating to the Works provided by the Minor Child, his or her written name credit as an author (individually or collectively with others, if appropriate) but only to the extent the Minor Child's name is provided by the Custodial Authority and Maison Battat Inc. determines that the inclusion of such credit is appropriate.

It is clearly understood by the Custodial Authority that Maison Battat Inc. has no responsibility nor obligation to make, print, sell, nor offer for sale any submitted materials by the Minor Child but, rather, Maison Battat Inc. has the entire right to decide how to use, make or publish or not to publish the submitted materials, if at all. In consideration of the acceptance by Maison Battat Inc. of the Minor Child's submission and Maison Battat Inc.'s decision to publish any or all of the same, Maison Battat Inc. may provide a one-time gift of products to the Minor Child, selected at Maison Battat Inc.'s discretion in quantity and value/amount, and without any further obligation to the Minor Child.

Further, it is a specific representation by the Custodial Authority, parent and/or guardian that the Minor Child identified above is the sole and exclusive author of the Work presented by him or her to Maison Battat Inc. and that the same has not been submitted to another entity for its commercial or non-commercial use nor exploitation.

Finally, the Custodial Authority, parent and/or guardian provides and grants, in addition to the rights provided by US and worldwide Copyrights, a full Release for the commercial use of the Minor Child's name and photograph, the release extending to the Minor Child's right of publicity, right of privacy, and credit for the Work, whether the information relating to the Minor Child is set forth in printed, visual or oral advertising, on packages, displays, marketing materials and/or on or in web content to the extent that the Custodial Authority, parent and/or guardian receives for the Minor Child's benefit the gift package of products, set forth above, from Maison Battat Inc. (at Maison Battat Inc.'s discretion in quantity and value) for the benefit of the Minor Child.
